Position Summary:

Applications are invited for the post of Lecturer/Assistant Professor in Crop Science in the School of Agriculture & Food Science. The appointee will join the Animal and Crop Science Section and will contribute to both undergraduate and postgraduate teaching, conduct high quality research in Crop Science and engage in associated administrative tasks. The appointee will join a highly motivated and research active Crop Science team who are involved with teaching and research in areas including cereal production, root and alternative crops, grassland, plant health, organic agriculture, digital agriculture and bioenergy.

The appointee will be expected to make significant teaching contributions in the broad area of crop agronomy from an Irish, European and global perspective, but will have specific expertise in one or more focused areas such as plant breeding, plant biology, plant pathology, crop physiology, smart phenotyping, stress resistance, nutrient efficiency, or integrated crop management.

The appointee will contribute to teaching on a number of programmes in the School, particularly at undergraduate level, but also at postgraduate level. Furthermore, the appointee will be required to develop a self-sustaining research programme in their area of expertise and actively contribute to the research output, operation and general academic responsibilities of the Section. They will be expected to work collaboratively with colleagues in the Section, School and University, and represent UCD nationally and internationally in their area of expertise.

The successful candidate will be offered a temporary position (estimated duration up to 3 years).

Appointment will be made on scale and in accordance with the Department of Finance guidelines.

Principal Duties and Responsibilities:

Duties will be as laid down by the relevant Head of School or their nominee and shall include lecturing, tutoring, research supervision, administration and research leading to scholarly publication and other outputs relevant to the Crop Science sector. While most of the teaching will be delivered at the main university campus in Belfield, the practical elements and the research activity may be split between the Belfield campus and the UCD Lyons Farm. As it is School policy to continuously update and improve its educational and research programmes, and to develop and implement new technologies in line with the needs of the University, it is essential that the appointee will be flexible in attitude and approach.

The main duties will include:

- Teaching basic/applied crop science to undergraduate and post graduate students embracing up-to-date state of knowledge including the results of on-going research.
- Contributing to the on-going development of teaching and learning programmes in cooperation with other

team members.

- Developing and sustaining an internationally recognized research programme that is consistent with the strategic plan of the School and University, and that leads to publications and innovation, and has impact.
- Disseminating the results of research through appropriate academic and social media channels.
- Supervising and mentoring undergraduate and postgraduate students, and early-stage researchers.
- Actively seeking research funding including competing for national and international grants
- Developing close collaborations with national and international scientists, members of the Crop Science industry and any other stakeholders.
- Representing UCD Agriculture both nationally and internationally in the specific areas of the appointee' s expertise.
- Contributing to the academic duties of the Section, School and University.
- Engaging in appropriate training and professional career development activities
- Undertaking other duties as assigned by the Head of School.

Selection Criteria:

Selection criteria outline the qualifications, skills, knowledge and/or experience that the successful candidate would need to demonstrate for successful discharge of the responsibilities of the post. Applications will be assessed on the basis of how well candidates satisfy these criteria.

Mandatory:

Applicants must have:

- A relevant undergraduate degree and a PhD in Crop Science.
- In-depth knowledge of crop productions systems in Ireland, Europe and worldwide.
- A demonstrated capacity to carry out crop science-related research which should be evidenced by the candidate's previous research experience and publication record.
- A vision and an ability to initiate a specific research programme in crop science that is relevant to the School and Irish agriculture. Ideally this will be in one or more areas of plant breeding, crop physiology, crop modelling, smart phenotyping, stress resistance, nutrient efficiency, integrated crop management.
- Experience in using advanced research methods and technologies.
- Teaching experience at third (undergraduate) and/or fourth (postgraduate) level.
- Ability to work on own initiative and as part of a team.
- Excellent interpersonal and communication skills.
- Candidates must demonstrate how they can positively contribute to fostering an inclusive environment and a level of awareness of equality, diversity and inclusion.

Desirable:

- A postgraduate qualification in teaching and learning.
- Experience in the development and delivery of on-line teaching
- Post-doctoral research experience in a relevant setting
- Experience in conducting collaborative research.
- A track record in preparation of research proposals and securing competitive research funding.
- Experience and interaction with the Crop Science industry.

a. **Pensionable Age** - The minimum age at which pension is payable is 66 in line with State Pension age changes.

b. Retirement Age - Scheme members must retire at the age of 70.

c. Pension Abatement:

• If the appointee was previously employed in the Civil Service or in the Public Service please note that the Public Service Pensions (Single Scheme and Other Provisions) Act 2012 includes a provision which extends abatement

of pension for all Civil and Public Servants who are re-employed where a Public Service pension is in payment. This provision to apply abatement across the wider public service came into effect on 1 November 2012. This may have pension implications for any person appointed to this position who is currently in receipt of a Civil or Public Service pension or has a preserved Civil or Public Service pension which will come into payment during his/her employment in this position.

• Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

• Ill-Health-Retirement

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

d. Prior Public Servant - While the default pension terms, as set out in the preceding paragraphs, consist of Single Scheme membership, this may not apply to certain appointees. Full details of the conditions governing whether or not a public servant is a Single Scheme member are given in the Public Service Pensions (Single Scheme and other Provisions) Act 2012. However the key exception case (in the context of this competition and generally) is that a successful candidate who has worked in a pensionable (non-single scheme terms) capacity in the public service within 26 weeks of taking up appointment, would in general not become a member of the Single Scheme. In this case such a candidate would instead be offered membership of the UCD Pension Scheme. This would mean that the abatement provisions at (c) above would apply, and in addition there are implications in respect of pension accrual as outlined below:

e. **Pension Accrual** - A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one existing public service pension scheme would apply. This 40-year limit, which is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012 came into effect on 28 July 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

f. Pension-Related Deduction - This appointment is subject to the pension-related deduction in accordance with the Financial Emergency Measure in the Public Interest Act 2009.
